Giftling Ideas:

Prayerfully consider that we are not seeking Equal Gifts, but Equal Sacrifice.

Things to consider for your gifting:

- Giving a regular monthly amount. For many people, giving a lump sum of \$4,800 would not be possible. By giving \$100/month, you could donate this amount over 4 years!
- Consider the tax savings of your gift. For instance, if you pay a combined rate of 30% between federal and state taxes, a \$20,000 gift may reduce your taxes by \$6,000! In this example, your gift of \$20,000 could actually cost \$14,000.
- Gift your tax savings to increase your gift amount! For example, if you are subject to a combined rate of 30% for federal and state taxes and you wish to make a gift of \$20,000:

In 2015	You gift the original \$20,000	= tax savings of \$6,000
In 2016	You gift the savings of \$6,000	= tax savings of \$1,800
In 2017	You gift the savings of \$1,800	= tax savings of \$540
In 2018	You gift the savings of \$540	= tax savings of \$162
In 2019	You gift the Final Gift of \$162	= Total Gifts of \$28,502!!
